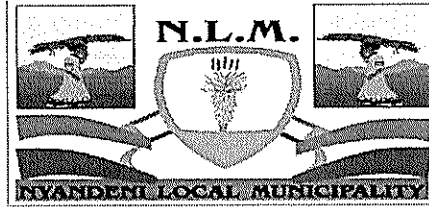

Bids should score a minimum of 60% for functionality in order to be considered for further evaluation.

Failure to submit the following document(s) may render the bid null and void:

- A copy of Company Registration Documents.
- Certified ID Copy(ies) of Director(s)
- Detailed Company Profile (with detailed list of projects undertaken thus far, their contract prices and contactable references)
- Entity Tax Compliance Status PIN & Entity Tax Reference Number (in writing, either on the company profile or any entity document with a letterhead)
- A certified copy or Original BBBEE Status Level Certificate or affidavit
- Proof of Residence or Address (for determination of locality of both the director and the company)
- Proof of CIDB Registration
- **Registration on the Central Supplier Database (CSD) is compulsory (proof of registration should be provided in writing)**
